- 2. The application form must be received by the Membership Department on or before 20th of the month (subject to changes) for it to effect on the 1st day after the next month (e.g. Forms received from by 20 January will take effect on 1 February).
- 3. Such transfer is subject to the approval of the General Committee and upon payment of a transfer fee. No reason shall be given for rejection.

No transfer shall take effect except upon payment of the prescribed transfer fee (inclusive of GST at 9%):

- 5. The completed softcopy transfer form, together with the proof of full payment of membership entrance or transfer fee, refundable deposit (\$300) and the following listed documents must be sent via email to Membership Department at membership@orchidclub.com.
 - (i) Softcopy or scanned copy NRIC/Passport/Employment Pass/Dependent Pass of each family member (where applicable).
 - (ii) Softcopy or scanned copy of marriage certificate and children's birth certificates (where applicable).
 - (iii) Electronic copy in JPG and PNG format photograph of each family member (where applicable)
 - (iv) Softcopy of Handicap
 - (v) Vehicle Log Card (if applicable).
- 6. Upon approval of the transfer, the Club will send an email to inform both the transferor/seller and transferee/buyer by the first day of the effective month. The Club shall not accede to any request that will delay or defer the transfer.
