### **APPLICATION PROCEDURES**

#### Membership Privileges

All applications for membership shall be subjected to the approval of the Club. The Club reserves the right to accept or reject any application without having to assign any reason whatsoever. The number of applications approved by the Club shall be determined by the Club at its sole and absolute discretion.

#### **Result of the Application**

Applicants shall be informed officially in writing by the Club regarding the outcome of their applications.

#### Successful Application

In the case where successful applicant wishes to withdraw, all monies paid to the Club shall be forfeited.

#### **Unsuccessful Application**

Unsuccessful applicant shall receive his/her funds without interest for the payment made. The Club shall not be held responsible for any loss or delay of the refund whatsoever or howsoever caused.

#### **Submission of Documents**

The completed softcopy transfer form, together with the proof of full payment of membership entrance or transfer fee and the following listed documents must be sent via email to <u>membership@orchidclub.com</u> Membership Department.

- (i) Softcopy or scanned copy NRIC/Passport/Employment Pass/Dependent Pass of each family member (where applicable).
- (ii) Softcopy or scanned copy of marriage certificate and children's birth certificates (where applicable).
- (iii) Electronic copy in JPG and PNG format photograph of each family member (where applicable)
- (iv) Softcopy of Handicap
- (v) Vehicle Log Card (if applicable).
